	5(A) SOW – ATTENDANCE MARKING SERVICE THROUGH BIOMETRIC AUTHENTICATION FACE RECOGNITION AND THUMB IMPERSONATION OR FACE RECOGNITION AND IRIS CAPTURING (Category-A) Rajasthan Staff Selection Board is keen to implement Biometric authentication system and facing recognition to make the examination process robust by implementing the mechanism from below such as - 5. A.1) Digital Fingerprint or iris capturing and facial recognition of candidate by verifying Candidate identity on real-time basis to monitor various activities of the candidates at the sub-centers spread at over the Rajasthan. Examination date and list of examination centers will be provided to the successful Bidder by the Rajasthan Staff Selection Board at least 1 to 2 weeks before the date of commencement	
4.	 I. Rajasthan Staff Selection Board will provide centre-wise data (Online Application ID, Roll numbers, Photos, Name, Exam date/shift etc.) of all registered candidates to the Bidder. Bidder will then use this data for Face recognition device & Finger-print or iris capturing and shall enable respective mechanism and candidate verification during the subsequent stages of the process. II. Bidder will have to install QR code scanner integrated hand-held device, Fingerprint and iris capturing scanner & Face recognition, along with adequate manpower at each & every Examination centre at the time of examination. III. Solution should have provision of real-time face recognition and verification, attendance monitoring system through secured web server. IV. Bidder has to maintain the entire database and application server at two different safe zones within India, making one site as DC (Data Centre) and other site as DR (Disaster recovery) during

work execution and has to submit data to RSSB within 07 days after exam. Bidder has to provide an affidavit mentioning all the captured data during SOW has been submitted to RSSB. Bidder should not keep these data on any server or any storage device. Bidder must not involve in data breach by any mean.

- V. QR code containing Online Application ID, roll number on the Admit card of the candidate should be scanned/read to auto-fetch the candidate details and in case, QR code is missing on admit card, then manual entry of roll number with candidate information has to be made. Thereafter, Finger print or iris capturing and Face capturing and verification of candidates frisking by the Hand-held device shall be done at the Security gate before the beginning of examination. All activities should be completed before conclusion or commencement of examination.
- VI. Bidder should deploy de-duplication algorithm across the database to avoid the duplicity of enrolment records.
- VII. Firm will capture live photo of the candidate at the exam centre for that:-
 - 1. Live Photo of OTR and scanned photo uploaded in online application form of the candidates appearing in the exam will be provided to the firm.
 - 2. QR Code on the admit card of the candidate will be scanned by the firm and details of the candidate will be captured.
 - 3. Live photo will be captured by the firm and will be stored with the name of application ID embedded in the QR Code.
 - 4. It will be stored/sent immediately on the server of the firm.
 - 5. At the same time, real time verification of the photos will be done using Al.
 - 6. Status of the photo verification to be shown immediately to the user and on dashboard of the system.
 - 7. For unverified photos an immediate alarm to be raised by the system.

There should be a dashboard for live reporting of the project.

Dashboard must have the capability to show centre wise live reporting of the project.

Dashboard must show live photo captured and photo provided by the board for real time decision making by the board in exceptional cases.

System must show the result of each candidate's photo verification.

- VIII. CPU configuration for running facial recognition: Sky Lake generation or later / updated technology versions.
- IX. The facial recognition should be performed in a completely stateless transaction of two images (one live image capture during the OTR passport size photo uploaded in form and the other one captured on the day of the exam).
- X. Image requirements for facial recognition
 - a. JPG
 - Face size: at least 60 pixels between eyes and a sharp image.
- XI. Biometric activity shall not be stopped on any ground and data capturing /identification work must be completed during the stipulated time period of the examination.
- XII. After the completion of activity as per scope, the Bidder will hand-over the entire captured data in HDD in a sealed manner with super scribing Exam Name along with report and forwarding letter duly signed by the Bidder to the Rajasthan Staff Selection Board within 7 days after the completion of the examination. Centre Superintendent (CS) will submit the CSR at RSSB directly.

- XIII. The Bidder shall not be allowed to take away any data either in hard copy or soft copy and the work is to be carried out in the designated exam centres.
- XIV. The Bidder will depute at least One Hand-held Fingerprint scanner, iris capturing device and Face capturing, recognition, verification device per manpower on every 80 candidates during different Examination stages as & when scheduled by Rajasthan Staff Selection Board. Additional Handheld devices should be made available as per normal practice in case of requirement.
- XV. The Bidder will have to ensure that the all the devices must be functional and capture Fingerprint or Iris & Photographs of each and every candidate who have appeared in the examination at centre
- XVI. If the examination is conducted in two or more shifts in a day at centres, the activity should be performed separately in all the shifts during the duration of examination.

After completion of work, Centre Superintendent (CS) has to submit centre-wise work completion certificate in the given format duly signed by the bidder's representative, Observer and Centre Superintendent to the Rajasthan Staff Selection Board.
